Ask Your Employer to Apply for the Partner Up! Grant Program

Project Growth is investing in Wisconsin businesses and child care providers that want to add services, find child care solutions, and innovate. How? By giving employers money to pay for the true cost of care for their employees! We offer funding and support to businesses and child care programs that partner up to help make high quality, affordable child care accessible and sustainable.

What is the Partner Up! Grant Program?

The Partner Up! grant program, implemented by the [Wisconsin Department of Children and Families](#) (DCF) and administered by [Supporting Families Together Association](#) (SFTA), focuses on supporting partnerships between businesses and child care providers by offering funding to businesses that purchase slots for employees' children at existing regulated child care providers. Awarded businesses, ranging from child care and health care to retail and manufacturing and everything in between, receive funding based on the true cost of care, number of slots, and age group.

How does the Partner Up! Grant Program Work?

Employers apply for a Partner Up! grant. Funding is calculated based on the true cost of child care. If awarded, the employer will help pay for a minimum of 25-35% of the true cost of care. Parents may contribute up to 10% of the true cost of care, unless the employer covers this for them. The Partner Up! grant program will cover the remaining percentage of the true cost of care.

Applications will be open from April 12-May 12, 2023 at 5 p.m. CST

BENEFITS FOR FAMILIES

- You can receive **quality local child care at little cost to you**. Employees of participating businesses will have a small parent pay portion of the true cost of care - the remainder of costs are covered by your employer and the Partner Up! program.
- It's likely **you can remain with your current child care provider** if their program is regulated and in good standing with DCF, and they agree to participate in Partner Up!
- Having reliable child care from a regulated program means **you can focus at work knowing your children are safe and in a high-quality environment**.

FREQUENTLY ASKED QUESTIONS

Who is Eligible to Apply?

All businesses except government entities are eligible to apply. Funding is targeted to businesses and families that would not normally be eligible for child care funding. Parents/caregivers who currently receive Wisconsin Shares or are participants in the Inclusive Birth to 3 Child Care Pilot are not eligible to receive sponsorship from Partner Up! at the same time.

What is the True Cost of Care?

The true cost of care is the cost to provide high-quality, developmentally appropriate, safe, and reliable child care staffed by a professionally compensated workforce. This amount is typically higher than going market rates, and much higher than most families can afford.

Will I Have to Change my Child Care Provider or What if I Need Help Finding Care?

If employees already use regulated child care programs, it's likely they could keep those providers. In the first two cohorts, 97.5% of families were able to keep their current providers! For employees who don't have existing child care, Partner Up! will match your employer with regulated local child care providers where slots are available.
