Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:  On 10/19/12, the agency received a report regarding a 5-year-old child who had been admitted to the hospital with significant injuries indicative of abuse. The mother stated the child had received the injuries from falling down the stairs while carrying groceries. The mother reported the child seemed fine at the time of the incident, but she became concerned about him the following day and took him to the hospital. The child presented with over 30 bruises to his face, neck, arms, legs and back. Halso suffered from pulmonary effusion, jejunal perforation, compartment syndrome to the left leg which required amputation, and kidney failure due to the severity of his injuries. Medical professionals stated that these injuries would not be caused by an accidental fall, but rather were indicative of physical abuse. The child died as a result of the maltreatment on 10/21/12. The mother's boyfriend was taken into police custody and has been criminally charged with one count of Child Abuse-Recklessly Cause Great Harm and one count of Neglecting a Child (Consequence is Death). The mother was also taken into custody and has been criminally charged with one count of Neglecting a Child (Consequence is Death). A criminal charge is merely an allegation and a defendant is presumed innocent until and unless proven guilty.
Findings by agency, including maltreatment determination and material circumstances leading to incident:  The agency collaborated with law enforcement and medical professionals to complete the assessment. Physical abuse to the child by the mother's boyfriend was substantiated. Neglect to the child by the mother and the mother's boyfriend was also substantiated. The mother's boyfriend admitted to "play boxing" with the child to toughen him up. The child received severe injuries from the mother's boyfriend, which resulted in his death. The mother was aware of the injuries her child received and failed to protect him or seek immediate medical attention. The agency has closed the case as there are no other children in the household.
