Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On September 4, 2014, the agency received a report regarding a six-year-old child pronounced deceased in the hospital. Law Enforcement was contacted and initiated a criminal investigation into the child's death. The child had been playing at the park, wandered away from mother and was later found unresponsive in a river near the park.

The Medical Examiner's Office report noted no signs of maltreatment or trauma to the child. The official cause of the child's death was determined as a freshwater drowning.

No criminal charges have been filed in this case and the investigation is closed.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect of the child by the mother. The Medical Examiner's Office completed report noted no signs of maltreatment or trauma to the child.

The agency determined the child's sibling was safe and the child remained with the mother. The family was referred to community services and the agency closed the case.

On October 1, 2013, the agency screened in a CPS Report alleging neglect of the then five-year-old child and his then eight-year-old sister by the mother. An assessment was completed by the agency and the allegation of neglect was unsubstantiated and the children were determined safe. On March 24, 2010, the agency screened in a Services Report. The agency provided the family with community resources.
