**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On May 21, 2016, the agency received a report regarding a 3 month old infant brought to the hospital with multiple injuries. Medical professionals who examined the infant diagnosed the infant with head trauma and transferred the infant to another hospital. Law enforcement was contacted and initiated a criminal investigation regarding the child's suspicious injuries. As a result of law enforcement's investigation, the father was arrested and criminally charged with Child Abuse - Intentionally Cause Great Bodily Harm. A criminal charge is merely an allegation and a defendant is presumed innocent until and unless proven guilty.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found a preponderance of evidence to substantiate maltreatment of physical abuse to the infant by the father. Medical professionals determined the infant sustained head injuries and diagnosed the infant with Traumatic Brain Injury, as well as extensive bruising on the back, abdomen, buttocks, and extremities. The infant and his sibling were deemed unsafe, taken into Temporary Physical Custody, and placed in a foster home. A Child in Need of Protection or Services petition was filed and the case remained open to provide ongoing case management services.

At the time of the incident, the agency was assessing reported allegations of child neglect to the infant and the infant's 18 month old brother by the infant's mother and father. The agency had face to face contact with the family on May 19, 2016.
