**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On August 1, 2021, the agency received a report of a 9-month-old infant who was brought to the hospital and pronounced deceased upon arrival. Law Enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office determined the death to be accidental. No criminal charges were filed, and the case was closed.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect of the infant by an unknown maltreater. The Medical Examiner's Office determined the death to be accidental. The agency determined the infant's siblings safe, and they remained with their mother and father. The agency closed the case upon completion of the Initial Assessment, and no service referrals were made.

On April 28, 2021, the agency screened-in a CPS Report alleging neglect to the infant's now 12-year-old and 13-year-old siblings by the mother, physical abuse to the infant's 12-year-old sibling by the mother, and sexual abuse to the infant's now 12-year-old sibling by an unknown maltreater. An assessment was completed by the agency, and all of the allegations were unsubstantiated. The case closed upon completion of the Initial Assessment.

On April 28, 2021, the agency screened-in a CPS Report alleging neglect to the infant's now 12-year-old and 13-year-old

siblings by the mother, physical abuse to the infant's 12-year-old sibling by the mother, and sexual abuse to the infant's now 12-year-old sibling by an unknown maltreater. An assessment was completed by the agency, and all of the allegations were unsubstantiated. The case closed upon completion of the Initial Assessment.

On April 29, 2019, the agency screened-out a CPS Report.

On November 27, 2012, the agency screened-in a CPS Report alleging physical abuse to the child's now 12-year-old sibling by the mother. An assessment was completed by the agency, and the allegation of physical abuse was unsubstantiated. The case was closed upon completion of the Initial Assessment.

On October 16, 2012, the agency screened-in a CPS Report alleging sexual abuse to the infant's now 12-year-old and 13-year-old siblings by an unknown maltreater. An assessment was completed by the agency, and the allegation of sexual abuse was substantiated. The family was referred to family-based services, and the case was closed upon completion of the Initial Assessment.

On April 18, 2011, the agency screened-in a CPS Report alleging neglect to the infant's now 12-year-old and 13-year-old siblings by the mother. An assessment was completed by the agency, and the allegation of neglect was unsubstantiated. The case was closed upon completion of the Initial Assessment.
