Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On September 6, 2021, the agency received a report regarding a 6-year-old child brought to the hospital with serious injuries. The child was pronounced deceased at the hospital. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office determined the death to be non-accidental. As a result of law enforcement's investigation, the mother was charged with Chronic Neglect of a Child and False Imprisonment. A criminal charge is merely an allegation and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the child by an unknown maltreater and a preponderance of the evidence to substantiate maltreatment of neglect to the child by the mother. The Medical Examiner's Office determined the death to be non-accidental. The child's 10-year-old and 9-year-old siblings were deemed unsafe, taken into Temporary Physical Custody, and placed in a licensed Group Home. Petitions for Protection or Services were filed, and the case remained open to provide ongoing case management services.

On June 25, 2019, another agency screened-in a CPS Report alleging neglect to the child's now 10-year-old and 9-year-old siblings by the mother. An assessment was completed by the agency, and the allegation of neglect was unsubstantiated. The family was receiving case management services related to Petitions for Protection or Services that were filed on May 8, 2017; the case remained open for ongoing case management.

On March 10, 2017, another agency screened-in a CPS Report alleging neglect to the child's now 10-year-old and 9-year-old siblings by the mother. An assessment was completed by the agency, and the allegations of neglect were unsubstantiated. Petitions for Protection or Services were filed on May 8, 2017, and the case was opened for ongoing case management.

On July 31, 2015, the agency screened-in a CPS Report alleging neglect to the child’s now 10-year-old and 9-year-old siblings by the mother. An assessment was completed by the agency, and the allegation of neglect was unsubstantiated. Another agency was providing ongoing case management services related to Petitions for Protection or Services that were filed on May 15, 2014; the case remained open with that agency for ongoing case management.

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Medical Examiner’s Office determined the death to be non-accidental. Petitions for Protection or Services were filed, and the case remained open to provide ongoing case management services.
