On April 13, 2022, the agency received a report regarding a 4-month-old infant brought to the hospital with multiple injuries. Law enforcement was contacted and initiated a criminal investigation. Medical professionals determined the injuries were consistent with non-accidental head trauma. No criminal charges have been filed, and the case was closed.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse of the infant by the infant's father. Medical professionals determined the injuries were consistent with non-accidental head trauma. The agency deemed the infant and the infant's half-siblings unsafe and initiated a Protective Plan. Subsequently, the infant and the infant's half-siblings were taken into Temporary Physical Custody. The infant was placed in a foster home, and his half-siblings were placed with relatives. Petitions for Protection or Services were filed, and the case remained open to provide ongoing case management services.
