**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On January 14, 2023, the agency received a report regarding a 2-month-old infant with multiple injuries brought to the hospital. Law enforcement was contacted and initiated a criminal investigation. Medical professionals determined the injuries were non-accidental in nature. As a result of law enforcement's investigation, the father was criminally charged with Child Abuse-Recklessly Cause Great Harm. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the infant by the father. Medical professionals determined the injuries were non-accidental in nature. The agency deemed the infant and the infant's siblings unsafe and initiated a Protective Plan. Subsequently, the infant's mother was assessed as protective, and the infant and the infant's 2-month-old sibling remained with the mother. The infant's 7-year-old half-sibling was returned to the care of her mother, and the 11-year-old half-sibling remained in the care of a relative. The agency closed the case upon completion of the Initial Assessment, and no service referrals were made.

On September 26, 2014, the agency screened-in a CPS Report alleging neglect to the infant's now 11-year-old half-sibling by the father and the half-sibling's mother. An assessment was completed by the agency with a determination of unable to locate, and the case was closed.
