Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On July 13, 2023, the agency received a report regarding a 9-year-old child and a 7-year-old child who were brought to the hospital due to injuries and concerns for their health and safety. Law enforcement was contacted and initiated a criminal investigation. Medical professionals determined the children's injuries were consistent with neglect. As a result of law enforcement's investigation, the mother was criminally charged with Chronic Neglect of a Child (Consequence is Emotional Damage), False Imprisonment, and Neglecting a Child (Specified Harm Did Not Occur). The mother's significant other was criminally charged with Chronic Neglect of a Child (Consequence is Emotional Damage) and False Imprisonment. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. Medical professionals determined the children's injuries were consistent with neglect. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect to the 9-year-old and 7-year-old children by the mother and the mother's significant other and insufficient evidence to substantiate maltreatment of physical abuse of the 9-year-old child by the mother. The agency deemed the 9-year-old and 7-year-old children unsafe and initiated a Protective Plan. Subsequently, they were taken into Temporary Physical Custody and placed in a non-relative foster home. Petitions for Protection or Services were filed, and the case remained open to provide ongoing case management services.
