#### Dear Senator Jauch:

This is the second installment of the Department of Children and Families' quarterly report on sexual abuse of children in out-of-home care placement, in compliance with 2009 Wisconsin Act 78. This document includes reports of sexual assault made April 1 through June 30, 2010 and fulfills the Department of Children and Families reporting requirements under Section 48.981 (9)(b), Wis. Stats. Also included in this report is an updated report containing current information on cases reported in the previous quarter.

## The following is the summary of reports received from April 1, 2010 through June 30, 2010.

Number of Incidents Reported: 28, Number of Incidents Substantiated: 1

DCF received reports of 28 suspected incidents of sexual abuse to children residing in an out- of- home placement during the second quarter. Of the incidents reported 36% or 10 cases were unsubstantiated. 17 cases are pending further investigation. Finally, only 1 of the incidents reported was found to be substantiated.

#### *Nature of Relationship:*

In the single case where sexual abuse was substantiated or confirmed, the maltreater was a peer who did not reside at the same residence as the victim.

#### Dates of the Incidents:

The incidents reported during the first quarter of 2010 are estimated to have occurred between January 1 and June 24, 2010. Children disclose abuse when they feel ready so it is common for abuse to be reported months or even years after the incident occurred. In cases of alleged abuse to younger children, dates of the alleged maltreatment may be difficult or impossible to determine due to the child's inability to effectively communicate about the incident(s).

### County in which the incident occurred: 13

Incidents were reported to DCF from throughout the state with multiple (i.e., more than one) incidents reported in Adams, Milwaukee, Outagamie, and Winnebago.

## Age or Age Group of child: 2-17 years

The Department received reports of suspected sexual abuse for children between the ages of 2-17. During this quarter, the lowest number of incidents (i.e., 1 incident per age group) reported were for children ages 4, 5, 13, 14, 16, and 17 years. Six-year olds were reported as the having highest number of reported incidents (i.e., five incidents for this age group) of suspected abuse.

# *Type of Placement: 8*

Reports of suspected abuse were disclosed while the children were residing in 8 different types of out-of-home placements. The alleged sexual abuse did not necessarily occur within the placement setting or by a maltreater in that setting, but rather that is where the child resided when he or she disclosed the abuse. Reports of suspected abuse came most frequently from non-relative treatment foster homes.
