Dear Assembly Chief Clerk Blazel and Senate Chief Clerk Queensland:

In compliance with 2009 Wisconsin Act 78, the Child Welfare Public Disclosure Act, please accept the Department of Children and Families' (DCF) 2022 second quarter report on alleged sexual abuse of children residing in out-of-home care. The data presented below addresses reports of alleged sexual abuse for the period April 1 through June 30, 2022 and fulfills the Department of Children and Families' reporting requirements under Section 48.981(9)(a), Wis. Stats.

We appreciate the legislature's interest in Wisconsin's child welfare system and their commitment to supporting DCF, county and tribal child welfare agencies, and the hundreds of non-profit organizations who work to protect Wisconsin children every day. Like you, we are saddened by all cases of child maltreatment and are committed to strengthening families. Wisconsin is fortunate to have dedicated and passionate child welfare workers and we want to recognize and express our appreciation for their commitment and compassion as they engage in these cases on a daily basis.

We encourage legislators and stakeholders to reinforce awareness that prevention of child maltreatment is a community-wide responsibility involving all individuals and organizations in the community, and to continue to support efforts at the local and state levels to develop a robust and consistent array of child maltreatment prevention services. Through collaborative and data-driven analyses and discussions, we all can support efforts to provide safe, stable, and nurturing homes for their children.

The following is a summary of the findings in the [report](#):

*Number of Reported Incidents: 46*

Wisconsin child protective services agencies screened in and investigated 46 reported incidents of suspected sexual abuse to 41 children residing in out-of-home care.

*Dates of the Incidents:*

The 46 reported incidents are estimated to have occurred between December 2016 and June 28, 2022. Because children disclose abuse in different stages, it is common for children to report incidents months or even years after the incident occurred. Furthermore, in cases of

alleged abuse involving non-verbal children, dates of alleged maltreatment are often difficult or impossible to determine.

*Maltreatment Determinations:*

Of the 46 reported incidents, maltreatment determinations were made for 14 (30%) of the reported incidents, while 32 (70%) maltreatment determinations are pending because the investigations are not complete.

Of the 14 reported incidents where the maltreatment determination was made, 11 (79%) were unsubstantiated (i.e., preponderance of the evidence indicating that sexual abuse occurred was not found), and three (21%) were substantiated.

*Nature of Maltreater Relationship:*

Of the three substantiated incidents, the relationship of the maltreater to the child was an employee at a Residential Care Center (RCC) in one incident, a minor maltreater in placement setting in one incident, and a non-caregiver in one incident. One of the substantiated incidents involved an allegation of sex trafficking.

*Types of Placement:*

Of the three substantiated incidents, one incident occurred while the child was placed at an RCC, one incident occurred while the child was placed at a non-relative foster family home, and one incident occurred while the child was placed at a group home.

*Location of Substantiated Incidents:*

Of the three substantiated incidents of sexual abuse to children residing in out-of-home care, one incident occurred in Burnett County, one incident occurred in Green County, and one incident occurred in Milwaukee County.

*Ages or Age Group of Children:*

The alleged sexual abuse was reported and investigated for children 2-17 years of age. The incidents of sexual abuse were substantiated for three children, one of whom was 8 years old, one of whom was 14 years old, and one of whom was 17 years old at the time of maltreatment.
