### Vision


All Wisconsin children and youth are safe and loved members of thriving families and communities.

## More than 1 in 10 children in Wisconsin are living below the federal poverty line.






## 1 in 3 households in Wisconsin face significant economic challenges.





#### Next steps . . .

- Expansion of TSSF:
  - Title IV-E revenue to expand program participation and service utilization.
  - Agencies that are not currently contracted
     TSSF will be able to receive funds for TSSF.
- Continuous quality improvement.

### **Family Keys**



A community-centered partnership to address housing-related child welfare barriers.



Partnering communities are developing action plans so that families have more stable housing, fewer child removals, or shorter stays in out of home care.



Participating counties have identified community-specific responses to stabilize families and are partnering to identify long-term, systemic improvements for implementation in 2023.

Keeping children in family settings.


#### **Kinship Consultation**

Met in August with tribal leaders to focus on supporting relatives.

- Some key themes:
  - Relatives need additional financial support.
    - Increase equitable support/parity with foster care
  - Relatives and agencies need administrative burdens reduced.
  - Forum for continued conversation needed.







### **Announcing: New Funding of \$7.5 Million**



Est. \$3 million for community-based treatment level foster care solutions.




Est. \$2-3 million for enhanced Qualified Residential Treatment Program (QRTP) solutions for specialized populations.



Est. \$1 million for a Group Care Clearinghouse.



# Supporting our workforce.



### **Child Welfare Professional Training**



A new model of initial training for newly hired CPS professionals.

- To improve the overall learning experience and better prepare our workforce.
- Reduced caseload requirement and increased local agency support.
- Toolkit will be able available for supervisors, mentors, lead staff, and coaches.
- Implementation and delivery in early 2023.



### **Safety Revisions**



Revisions to the safety assessment and planning process.

Revisions to the danger threat language.

... to be culturally responsive, equitable and just.

- Rolled out language changes to danger threats in June.
- Where we're heading:
  - Additional recommendations for revising the safety assessment and planning process (using feedback);
  - Using data to inform decisions;
  - and identifying opportunities for feedback in 2023.



### Family Legal Advocacy and Supports (FLAS)



Provide quality legal advocacy and supports for families, with a focus on family law and civil legal representation.

- Establishment of a multidisciplinary team.
- Meetings with counties to identify legal needs.
- Determined program eligibility criteria for services:
  - There is no active TPC or CHIPS case;
  - The individual or family has an unmet need for civil legal services;
  - and participation in the program is voluntary.
- Launched the FLAS in September.



### **Updated Federal Guidance: Child Support**

Research demonstrates: not cost-effective.<sup>1</sup>




Against a child's best interest.



Likely already living in poverty.



Family instability and separation.



Coordinate with local child support agencies.


