Request Replacement Card Reason Details

A request for a replacement card cannot be processed for any of the following reasons:

- If a child already has two active Medicaid cards, the Forward Health system cannot determine which one or both active cards should be deactivated. The worker will receive an error message to contact member services.
- If a client has a bad address on the file, the request cannot continue. A bad address on file occurs when Forward Health receives an ID card returned because it was undeliverable.
- If a previous request was submitted in the last 7 calendar days for the same card type, the request will be denied. This will prevent a duplicate card from being sent out.
- If the request is not processed and a replacement card is needed contact member services at (800)362-3002.
