

eWiSACWIS Release 2.9 Release Summary September 24th 2007

From CPS to Services Report or vice versa) the worker recommendation information was overwritten with the supervisor's name and decision. With this change we will no longer overwrite the worker recommendation info w/ supervisor information.

22840	Maintain Case	Adoptions	State	The case adoption copy batch will now generate a unique agreement id (ID_AGRM) when the adoption assistance agreement and amendment are copied from the Pre-Adoptive Child case to the Adoptive Home case. This allows these documents to be opened without error.
20005	Maintain Services	Provider	Langlade	The Maintain Service Types page will no longer display a Fatal Application Error when a value of No Data Found displays in a field.
22200	Manage Documents	Ongoing	State	The enhancement changes the CFS-2322 - Screening for Child's Status as Indian template. Updates the revision date to be 12/06, removes the "Name Updated By" Section, and provides some minor wording changes. Also, the checkboxes for question #8 "Is the child adopted?" are enabled.
6607**	Medical	All	Milwaukee	This enhancement modifies the system so a person's medical and mental health information is centrally located for the worker while including new fields that will allow workers to enter a more comprehensive description of a case participant's health concerns. The worker will no longer use the Create>Case Work process but rather will access and supplement the existing person management record with medical mental health information. Please see the web cast presentation for upcoming changes for additional details.
23016	Merge Person	Eligibility	State	When merging Persons who both have Medicaid Eligibility IDs, batch processing has been modified to only retain one Medicaid Eligibility ID from the Retain Person record while bringing over certifications rows associated with the Remove person record.
23035	Mobile Computing	Tablets and Laptops	State	Within eWiSACWIS Anywhere, if a user does not enter the time at which a contact occurred and clicks save, the system will now throw a validation error message prompting the user to enter the date.

23150	Person Management	Reporting	State	This changes the Child turned 18 batch, which was updating adoption funding records when a child aged out of their eligibility, but was not indicating the sign-off was completed.
23157	Person Management	Reporting	State	Corrects the logic of the Child Turned 18 batch to properly handle situations where children's eligibility past age 18 has their placement end, but then returns to care (without a break). The batch was incorrectly ending the Federal eligibility as of the ending of the first placement. It will now leave the Adoption Funding status as open when appropriate.

23112	Trust Accounts	Financial	State	An updated sort on the Non-WiSACWIS Benefits View page prevents the same reference ID records from being displayed multiple times.
