The COPPER County Child Support Agency has initiated an administrative intercept, pursuant to §49.856 Wis. Stats., against your interest in the insurance claim designated above.

If you request a hearing, we will inform the insurance company to hold the funds until the child support agency issues a final decision to them based upon the court's ruling at the hearing.

How To Calculate the Percentage for multiple court cases EXAMPLE

	Court Case Lien Balance (04, 18)	Calculate the Percentage amount	Total Intercepted Amount	Proportionate amount
Court case 1	\$1,950	$\$1,950/\$3,400 = 0.57$	\$2000	$\$2,000 \times 0.57 = \$1,140$
Court case 2	\$1,450	$\$1,450/\$3,400 = 0.43$	\$2000	$\$2,000 \times 0.43 = \860
