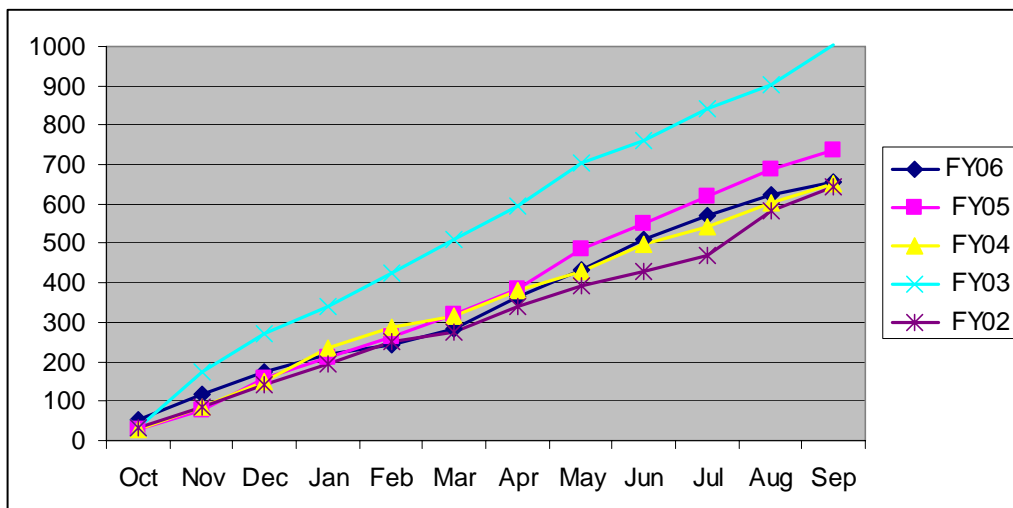

## Contract Activity by year for the last 5 years



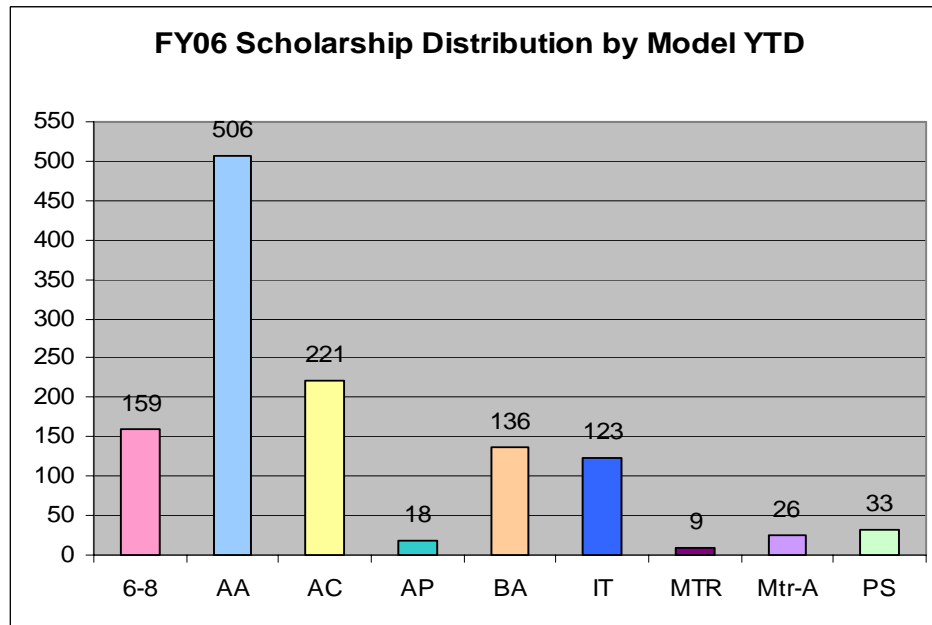
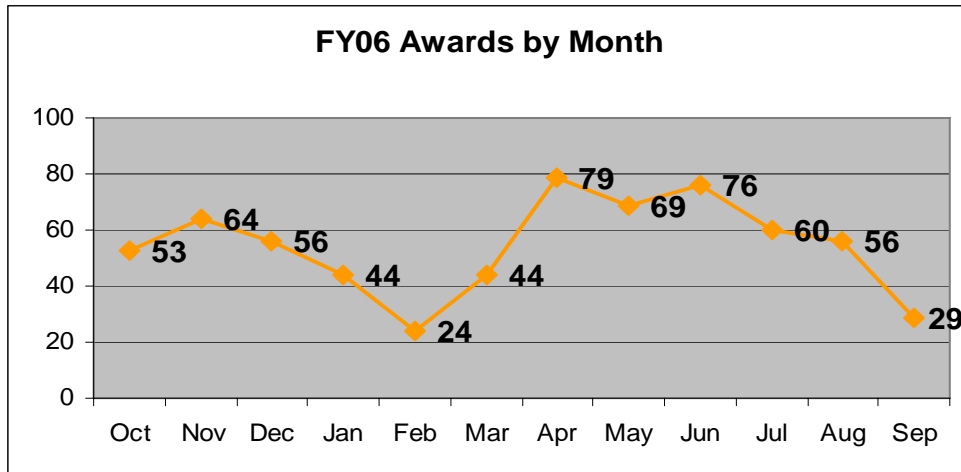

 Each center sponsored an average of **3** employees.

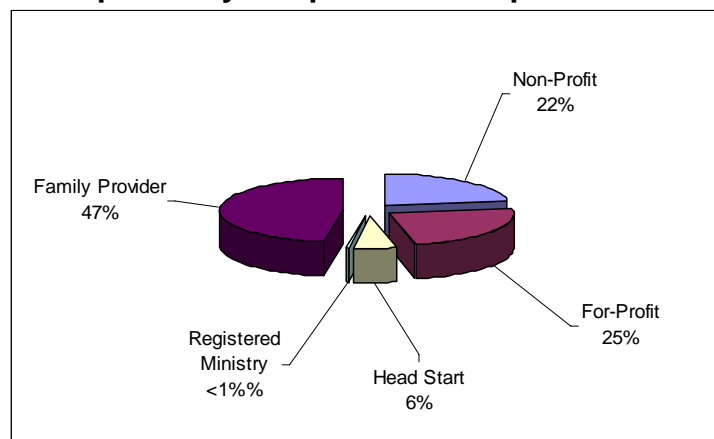
Over **27%** of the **380** group centers sponsored **3** or more employees

County of Residence for T.E.A.C.H Scholarship Recipients Fiscal Year 2006

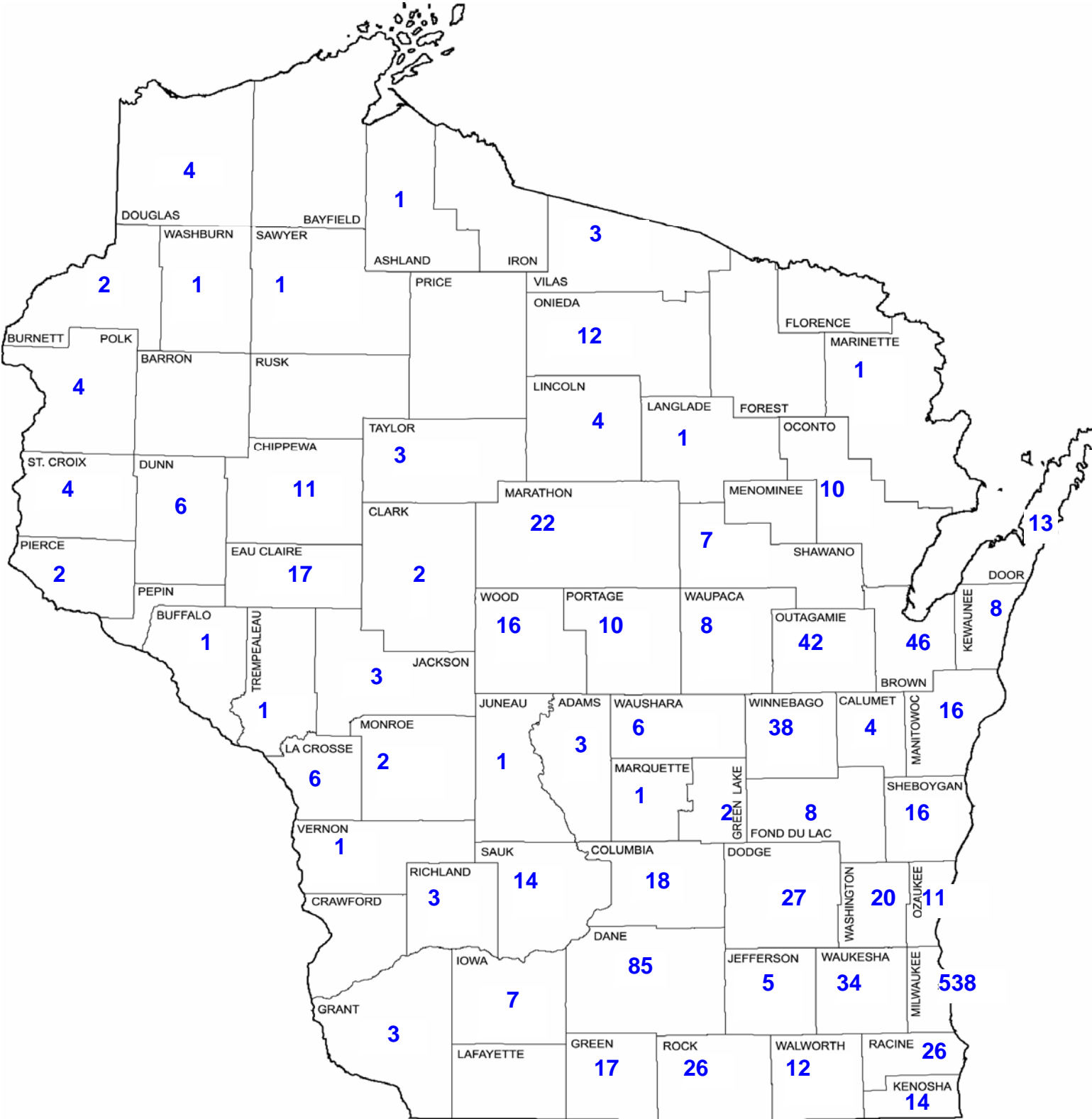
