Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On January 2, 2026, the agency received a report regarding a 2-month-old infant pronounced deceased in his home. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office noted no signs of trauma to the infant; the autopsy report is pending. No criminal charges have been filed in this case, and the investigation remains open.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect or physical abuse of the infant by an unknown maltreater. The infant's siblings were deemed safe, and they remained with their mother. The agency closed the case upon completion of the Initial Assessment, and no service referrals were made.

At the time of the incident, the infant resided with his mother, his 2-month-old twin sibling, his 1-year old sibling, his mother's significant other, his grandmother, and his maternal uncle. Paternity had not been established for the infant.

At the time of the incident, the agency was assessing the December 18, 2025 CPS Report. The last contact by the agency was with the mother and twin infants on December 31, 2025.

On December 18, 2025, the agency screened-in a CPS Report alleging neglect to the infant and the infant's 2-month-old twin sibling by the mother.
