Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On January 24, 2026, the agency received a report regarding a 2-year-old child brought to the hospital unresponsive. Law enforcement was contacted and initiated a criminal investigation. Medical professionals determined the injuries were non-accidental in nature. As a result of law enforcement's investigation, the child's non-relative caregiver was charged with Neglecting a Child -Consequence is Great Bodily Harm. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect and physical abuse to the child by the child's non-relative caregiver. The agency determined the child and the non-relative caregiver's children unsafe and initiated a Protective Plan. Subsequently, the child and the non-relative caregiver's children were taken into Temporary Physical Custody. Upon discharge from the hospital, the child was placed in a non-relative foster home. The non-relative caregiver's children were placed with relatives. Petitions for Protection or Services were filed, and the case remained open to provide ongoing case management services.
