Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On January 29, 2026, the agency received a report regarding an infant found unresponsive in their home and who was later pronounced deceased at the hospital. Law enforcement was contacted and initiated a criminal investigation. Medical professionals determined the child had been exposed to controlled substances; the autopsy report is pending. No criminal charges have been filed related to the infant's death, and the investigation remains open.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect of the infant by the mother and found insufficient evidence to substantiate neglect of the infant by an unrelated adult. The agency closed the case upon completion of the Initial Assessment, and no service referrals were made.

At the time of the incident, the family was under an Informal Dispositional Agreement related to the November 25, 2025 CPS Report. The last contact by the agency was with the mother and infant on January 7, 2026.

On November 25, 2025, the agency screened-in a CPS Report alleging neglect to the infant by the mother.
