Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On February 17, 2026, the agency received a report regarding two children, ages 11-years-old and 13-years-old, who had multiple injuries. Law enforcement was contacted and initiated a criminal investigation. Medical professionals determined the injuries were non-accidental in nature. As a result of law enforcement's investigation, a non-relative caregiver of the children was criminally charged with Child Abuse-Intentionally Cause Harm. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the children by the non-relative caregiver. The agency determined the children safe, and they remained with their father. The agency determined the non-relative caregiver's children and the non-relative caregiver's significant other's child safe, and they remained with the non-relative caregiver and the non-relative caregiver's significant other. The family was referred to community services, and the agency closed the case upon completion of the Initial Assessment.
