**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On March 17, 2026, the agency received a report regarding a 1-month-old infant brought to the hospital with injuries on March 16, 2026. Law enforcement was contacted and initiated a criminal investigation. Medical professionals determined the injuries were non-accidental in nature. As a result of law enforcement's investigation, the infant's father was charged with Child Abuse-Reckless Probable/Great Harm. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the infant by the father. The agency deemed the infant and the infant's half-sibling unsafe and initiated a Protective Plan. Subsequently, the infant and the infant's half-sibling were taken into Temporary Physical Custody and placed with a like-kin foster home. Petitions for Protection or Services were filed, and the case remained open to provide ongoing case management services.
