On April 13, 2026, the agency received a report regarding a 3-year-old child pronounced deceased. Law enforcement was contacted and initiated a criminal investigation. Medical professionals noted no signs of trauma to the child; the autopsy report is pending. No criminal charges have been filed in this case, and the investigation has been completed.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect of the child by the mother and the father. The agency deemed the child's siblings unsafe and initiated a Protective Plan. Subsequently, the father was assessed as protective, and the children remained with the father. The agency closed the case upon completion of the Initial Assessment.
