On May 16, 2026, the agency received information regarding a 16-year-old youth who was in out-of-home care and was found deceased. The Medical Examiner's autopsy report is pending. No criminal charges have been filed in the case, and the investigation remains pending.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

There were no allegations of abuse or neglect, therefore an Initial Assessment was not completed, and no substantiation decision or safety determination findings were made by the agency. The family was referred to services, and the agency closed the case.
