


CSEC and DMST Legislation in Connecticut

- Minors under the age of 18 cannot be arrested for prostitution.
- Victims of CSEC/DMST are guaranteed an affirmative defense, and have the right to vacate related juvenile records.
- Victims of CSEC/DMST can be classified as "uncared for" in order for DCF to provide services.
- Suspected cases of CSEC/DMST shall be reported to the DCF Careline (800-842-2288).
- CSEC/DMST cases are to be addressed through Multi-Disciplinary Teams (MDTs).

Connecticut Referrals....

- 2008 to present Over 500 children and youth referred
- Trafficking type: DMST/CSEC
- Vulnerability: Majority of victims were on runaway/AWOL status; Majority of victims had experienced sexual abuse and/or neglect.
- Age range: 2 − 18
- Referrals: DCF Social Workers, Law enforcement, EMS, congregate care facilities, Courts, public defenders' office, NGOs, etc...

Identification and Response

- DCF Careline Responds to EVERY Call
- HART (Human Anti-Trafficking Response Team)
- MDT (Multi Disciplinary Team) Lead Role
- Designated Emergency Department(s) across the state
- Rapid Response
- DCF Response Practice Guide
- Relationships established with FBI, United States District Attorney, Homeland Security and local law enforcement.

Awareness and Education

- DCF Academy offers 3-days of specialized trainings; Day 1, Day 2 and Demand.
- DCF awareness efforts on CSEC/ DMST include Chief of Police/ roll call trainings, juvenile and adult judges, emergency medical providers, MDT teams, service providers, educators, medical providers, foster parents, etc....
- Education to Connecticut young people: service providers, schools and community.
- Prevention curriculum for girls/boys/ LGBTQI: Not a #Number (Love 146). https://love146.org/notanumber/
- Specialized curriculum for girls; My Life My Choice (JRI).
- National consultation on best practices for child welfare systems and provider networks.
- Newest curriculums and Model: 1) Foster Care Model with Training and 2) Boys/ Male Bodied Youth and CSEC/ DMST.
- Training of Trainer (TOT) efforts.






