**ABUSIVE HEAD TRAUMA PREVENTION TRAINING FOR CHILD CARE PROVIDERS.** Wisconsin Child Abuse and Neglect Prevention Board and Wisconsin Department of Children and Families, in consultation with the National Center on Shaken Baby Syndrome. This online training meets Wisconsin's requirement that child care providers and preschool teachers, before they work with children under age 5, receive training on Abusive Head Trauma prevention, including Shaken Baby Syndrome prevention, and how to manage crying, fussing, or distraught children.

Text read by a child of an adult's best guess at what the prenate, baby, or toddler sees, feels, and concludes about domestic violence.

The harsh reality of child abuse and neglect is discussed with professionals who share information regarding the indicators of abuse and neglect, what to do if abuse is suspected, and policies you can put in place to decrease the chance of abuse.

Certain people in Wisconsin are required, either by state statutes or by an executive order of the governor, to report suspected child abuse and neglect. This training covers the legal responsibilities of a mandated reporter, the types of child abuse and neglect and their definitions, how to recognize child abuse and neglect, how and where to make a report, what happens after you make a report, and the protections for a reporter under the law.

A sentinel injury is a fairly minor abusive injury that occurs before a baby is mobile and prior to a more serious physical injury. Detection of sentinel injuries with appropriate interventions can prevent many cases of abuse. This module helps child care workers, child welfare workers, family support staff, and home visitors identify these warning signs and respond effectively if they suspect abuse.

A nationally recognized child abuse specialist addresses the injuries that can occur if a baby or young child is violently shaken by a parent or caregiver who reacts in anger and frustration to the infant's inconsolable crying. She also gives insight into the prevention of this serious form of child abuse.
