RE: Revisions to DCF 251 – Licensing Rules for Group Child Care Centers

Creation of DCF 13 – Child Care Background Checks

The primary purpose of the emergency rule changes is to ensure that, by September 30, 2019, the department's licensed group child care rules comply with the health and safety requirements found in the Child Care and Development Block Grant (CCDBG) Act of 2014. The rule also regroups the licensed group rules that address the same topics in different places, eliminates duplicative revisions, corrects errors, incorporates state statutory requirements and clarifies language where needed to ensure proper implementation and administration of the health and safety requirements.

Summary of DCF 251 Licensing Changes

This memo does not include every repeal, revision, or addition to DCF 251 and should not be used as a substitute for a thorough review of the revised group licensing rules.

Staffing and Supervision Rule Changes:

- 1. Group child care workers may care for children up to 12 hours per day.
- 2. Children may be in care for up to 14 hours per day.
- 3. CPR and automated external defibrillator (AED) training will need to be completed within 3 months of becoming licensed or beginning to work with children in care.
- 4. The rules related to emergency planning will be clarified to specify that emergency plans must include procedures that address evacuation, relocation, shelter-in-place, lock-down, communication with parents, procedures that ensure that the needs of children under age 2 and children with disabilities are met when utilizing emergency procedures, food emergencies, and allergic reactions.
- 5. Orientation topics have been expanded to ensure CCDBG topics are covered.

Staff Qualification Rule Changes:

- 1. Staff qualifications have been modified. Director of 50 or fewer children and teacher experience requirement has been modified from 80 full days or 120 half days to 320 hours.
- 2. Qualifications for staff that work exclusively with school-age children will be expanded to include additional types of allowable education and experience.

DCF-F-2618-E (R. 01/2019) www.dcf.wisconsin.gov 3. Programs for school-age children have additional exceptions to the licensing rules that will automatically apply.

Transportation Rule Changes:

- 1. Drivers need a training before they can transport children, and annually thereafter.
- 2. No child may be in a vehicle for transportation to or from a center, a field trip, or other center activity for more than 60 minutes for a one-way trip.
- 3. Rules have been added regarding the use of cellular phones, other wireless communication devices, and navigation devices.

Other Rule Changes:

- 1. Requirements limiting the movement of infants and toddlers between groups of children were removed. Infants and toddlers must still have a consistent caregiver, but centers will now be allowed to move children to accommodate staffing needs.
- 2. Rules will be consolidated and grouped with other similar rules, such as personal hygiene (handwashing), medical log books, children's records, and staff files.
- 3. Rules regarding safe sleep environments have been updated. No soft or loose objects are allowed in cribs or playpens for children under 1 year of age, including blankets, flat sheets, and pacifiers with attached soft objects.

DCF 13 Rule Creation

DCF 13 Background Checks for Child Care Programs, is based on the existing requirements under s. 48.686, Stats. The newly created DCF 13 includes provisions on submitting a background check request to the department and the required appeal process.
