## Welcome

- Secretary Amundson started the meeting at 1:00 p.m.
  - Roll call is taken.
- Approval of minutes
  - o June 2023: Secretary Olson-Collins moves; Rebecca Murray seconds.
  - October 2023: Dr. Underly Moves, Tracy Luber seconds.
  - February 2024: Secretary Pechacek moves; Secretary Blumenfeld seconds.
  - All minutes approved.
- Secretary Amundson introduces topic of the day, Wisconsin Shares, which is Wisconsin's child care subsidy.
  - A background will be given about Wisconsin Shares, including eligibility requirements, communications campaign, and ideas for how to expand eligibility.

#### Wisconsin Shares 101

- Priya Bhatia, DCF Division of Early Care and Education Administrator gave presentation on Wisconsin Shares history and overview, program requirements including eligibility and authorizations, and program administration and implementation.
- Wisconsin Shares is a child care subsidy program that assists low income families with the cost of child care.
  - Primarily funded by TANF block grant and the federal Child Care Development Fund (CCDF).
- In order to be eligible, participants must not exceed 185% of federal poverty level (FPL) and cannot exceed 85% of the state median income (SMI).
  - $\circ$   $\,$  Can apply online, in person, or over the phone.
- Authorization is an approval for the monthly subsidy.

• Funds issues by an EBT card.

# Wisconsin Shares Communications Campaign

- Gina Paige, DCF Communications Director, presented communications campaign around Wisconsin Shares.
  - Used paid media campaigns, web redesign, and tool kits for parents and providers.
  - Paid media campaigns were statewide via TV ads, billboards, streaming audio, and digital video.
- Gina shared that the Wisconsin Shares Partner Tool Kit can be shared by other agencies to help promote program.
- Secretary Amundson asked members to brain storm how they can share the Wisconsin Shares information in their own agencies.
  - Public health departments, nurses, and 211.
  - Melissa Roberts said they can post flyers in Community Corrections Offices.
  - Cari Redington wants to explore communications options at DOR, such as communications online during tax time.
  - Elmer Moore asked about categorical eligibility, which Sec. Amundson said that they are interested in exploring.
  - Secretary Blumenfeld can look into broadband eligibility.
  - Secretary Pechacek suggested posting at job fairs.

## Innovative Uses for Child Care Subsidy in Other States

- Jordan Hynes from the National Governors Association (NGA) gave presentation on how other states are using their child care subsidies and categorical eligibility to meet specific workforce needs.
- Federal statute caps threshold of eligibility at 85% of SMI.
  - As of 2023, all but 16 states set below 85% of median income. Wisconsin is at 53%.
- Shared some states who are trying interesting models:
  - Louisiana: leader in implementing affordable child care subsidy through increased reimbursement rates and lowers costs. 150% FPL pay no out of pocket costs for child care.
  - Montana: recently codified program to low income families for child care.
  - Nevada: Access limited to 130% FPL, but increased to families of 4 making \$70k a year.
  - Michigan: in 2022, expanded income eligibility.
- Group discussed other strategies states have used and members asked questions around categorical eligibility, Michigan's tri-care model, and philanthropy to meet the gap between subsidies and true cost.
