- States are required to develop and implement Early Learning Development Guidelines (ELDGs) by a federal law: the Child Care Development Block Grant (CCDBG) Act of 2014.
- Who uses Wisconsin's ELDGs, the WMELS?
 - o 4K/5K
 - Child Care
 - Head Start
 - Early Childhood Special Education
 - Early Intervention
 - Pre-service Course Instructors
 - o In-service Professional Development Trainers
- Three workforces interested in expanding their background on child development through use of ELDGs:
 - Home visiting
 - Family Resource Centers (Family Educators)
 - UW Extension Educators
- The WMELS Revision project goals are as follow:
 - Goal 1: Collaboratively develop updated Early Learning and Development Guidelines (ELDGs) that are aligned with feedback from system partners as well as current best practices and research for healthy early childhood physical and mental development and well-being.
 - Goal 2: Collaboratively update any contextual and supporting components of the ELDGs document (such as guiding principles, resources, etc.) that are aligned with current research and trends in the field.
 - Goal 3: Establish a revision process and cadence of revisions for future on-going management of the ELDGs.
 - Goal 4: Develop an on-going implementation plan and infrastructure for the newly revised ELDGs that meets the needs of all ECE professionals who work with young children and their families across a variety of settings.
- The project will include extensive partner engagement throughout.
- Marzano Research was the winner of a recent procurement process led by DCF with support from DPI and DHS. They are leading a discovery process including:
 - Literature review (existing documents and research)
 - Review of other states' ELDGs and current trends
 - o Extensive partner engagement across Wisconsin
 - A summary report and presentation of findings

- Recommended enhancements to WI ELDGs and supporting content such as guiding principles, appendices, and other guidance
