Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:
On October 16, 2014, the agency received and screened in a report regarding an 11-week old baby who had been pronounced dead in his home by emergency medical personnel. Law enforcement was contacted and a criminal investigation was initiated. Preliminary report from the medical examiner's office indicated the cause of the child's death to be asphyxia due to overlay. As a result of law enforcement's investigation the maternal grandmother was arrested and criminally charged with one count of 2nd Degree Reckless Homicide. A criminal charge is merely an allegation and a defendant is presumed innocent until and unless proven guilty.
Findings by agency, including maltreatment determination and material circumstances leading to incident: The agency screened in and assessed allegations of neglect to the 11-week old and his 12 and five-year old siblings by the mother and to the maternal grandmother and maternal great-aunt, who were visiting the family home at the time of the incident. The agency collaborated with law enforcement and medical personnel to complete the assessment. The assessment completed by the agency found sufficient evidence to substantiate neglect of the children by the maternal grandmother. The surviving children were assessed as safe, the family was provided with referral resources for mental health and substance abuse services, and the case was closed.
