Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On February 27, 2016, the agency received a report regarding an infant who was pronounced deceased. Law Enforcement was contacted and initiated a criminal investigation into the infant's unexplained death. Medical personnel diagnosed the infant with congenital issues, including retinal issues and vocal cord paralysis that resulted in the infant's death. No criminal charges were filed in this case and the investigation was closed.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect of the child by the mother. The Medical Examiner's Office noted no signs of maltreatment or trauma to the infant. The agency determined the infant's sibling to be safe and the sibling remained with the mother. Upon completion of the Initial Assessment, the case was closed and no further service referrals were made.
