**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On May 20, 2021, the agency received a report regarding an 11-month-old infant pronounced deceased in his home. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office noted no signs of trauma to the infant. The autopsy report as well as the toxicology results are still pending. No criminal charges have been filed in this case and the investigation remains open.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect of the infant by the mother. The Medical Examiner's Office noted no signs of trauma to the infant. The family was referred to community services, and the agency closed the case upon completion of the Initial Assessment.

At the time of the incident, the infant resided with his mother, his maternal grandmother, and his maternal uncle. Paternity was established, and the infant was having regular visits with his father.
