#### Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On May 4, 2022, the agency received a report regarding 1-year-old infant, who was in out-of-home placement with an unlicensed relative, who was brought to the hospital and subsequently pronounced deceased on May 3, 2022. Law enforcement was contacted and initiated a criminal investigation. Medical professionals determined the death to be non-accidental. No criminal charges have been filed in this case, and the investigation remains open.

#### Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect to the infant by the mother and the father. Medical professionals determined the death to be non-accidental.

At the time of the incident, the infant was residing in an unlicensed relative home. The infant was originally placed in out-of-home care on January 13, 2022, after he was taken into Temporary Physical Custody due to allegations of neglect by his father.

At the time of the incident, the infant resided with his aunt and uncle, and there were three other children in the home. The infant was with his mother and father when the incident occurred.
