Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On July 7, 2023, the agency received a report regarding a 2-month-old infant brought to the hospital with multiple injuries. The infant was later pronounced deceased on July 8, 2023. Law enforcement was contacted and initiated a criminal investigation. Medical professionals determined the injuries were non-accidental in nature. No criminal charges have been filed in this case, and the investigation remains open.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. Medical professionals determined the infant's injuries were non-accidental in nature. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the infant by the mother. The agency deemed the infant's sibling safe with relatives and closed the case upon completion of the Initial Assessment.

At the time of the incident, the agency was assessing a June 26, 2023, CPS Report alleging neglect to the infant by the mother and father. The last attempted contact by the agency with the mother and father was on June 28, 2023.
