On March 23, 2024, the agency received a report regarding a 9-year-old child brought to the hospital with multiple injuries. La enforcement was contacted and initiated a criminal investigation. Medical professionals determined the injuries were non-accidental in nature. As a result of law enforcement's investigation, the father was criminally charged with Child Neglect. criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.	
Findings by agency, including maltreatment determination and material circumstances leading to incident:	
The agency collaborated with law enforcement and medical professionals to complete the assessment. Medical professionals determined the injuries were non-accidental in nature. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the child by the father. The agency determined the child and the child's siblings unsafe and initiated a Protective Plan which subsequently transitioned to an in-home safety plan with the mother An Informal Dispositional Agreement was filed, and the case remained opened for ongoing case management services.
