### Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On June 12, 2024, the agency received a report regarding a two-year-old child pronounced deceased in his home. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office noted no signs of trauma to the child; the official cause of death was undetermined, and the toxicology results were negative. No criminal charges have been filed in this case, and the investigation remains open.

### Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Medical Examiner's Office noted no signs of trauma to the child; the official cause of death was undetermined, and the toxicology results were negative. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect of the child by the child's uncle. The child's sibling who resided with the uncle was returned home with the mother. The agency closed the case upon completion of the Initial Assessment, and no service referrals were made.

At the time of the incident, the child was residing in an unlicensed relative home. The child was originally placed in out-of-home care on May 11, 2024, after he was taken into Temporary Physical Custody due to allegations of neglect by the mother.

At the time of the incident, the child resided with his 10-month-old sibling, his maternal uncle, and his maternal uncle's significant other.
