**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On October 26, 2024, the agency received a report regarding a 3-week-old infant who was transported to the hospital and subsequently pronounced deceased. The Medical Examiner's Office noted no signs of trauma to the infant; the autopsy report is pending. No criminal charges have been filed in this case, and the investigation remains open.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Medical Examiner's Office noted no signs of trauma to the infant; the autopsy report is pending. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect of the infant by the father. The infant's half-siblings were deemed safe and remained with the mother and the infant's father. The family was referred to community services, and the agency closed the case upon completion of the Initial Assessment.

At the time of the incident the infant, resided with her mother, her father, and her twin 17-year-old half-siblings.

At the time of the incident, the agency was assessing the October 9, 2024 Services Report. The last contact by the agency was a home visit with the mother on October 21, 2024.

On October 9, 2024, the agency screened-in a Services Report to offer services to the family. The infant died during the assessment period, and an additional report was made to the agency regarding the infant's death on October 26, 2024. The agency connected the family to community services as part of the initial Services Report.
