On March 10, 2025, the agency received a report regarding a 3-month-old infant brought to the hospital with a serious injury. Law enforcement was contacted and initiated a criminal investigation. Medical professionals determined the injuries were non-accidental in nature. No criminal charges have filed in this case, and the investigation remains open.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect to the infant by the mother. The agency closed the case upon completion of the Initial Assessment, and no service referrals were made.

On January 21, 2025, the agency screened-in a CPS Report alleging neglect to the infant by the mother.
