**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On April 19, 2025, the agency received a report regarding a 2-month-old infant brought to the hospital with multiple injuries. Subsequently, the infant was pronounced deceased on April 25, 2025. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office determined the infant's death was non-accidental. No criminal charges have been filed in this case, and the investigation remains open.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the infant by the infant's mother and father. The agency determined the infant and the infant's half-sibling unsafe and initiated a Protective Plan. Subsequently, the infant passed away, and the infant's half-sibling was taken into Temporary Physical Custody and placed with a relative. A Petition for Protection or Services was filed, and the case remained open to provide ongoing case management services.

An assessment of the initial allegation was completed by the agency, and the allegation of neglect was unsubstantiated.
