Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On April 23, 2025, the agency received a report regarding a 4-month-old infant brought to the hospital with a serious injury. Law enforcement was contacted and initiated a criminal investigation. Medical professionals determined the injury was non-accidental in nature. As a result of law enforcement's investigation, the mother's significant other was charged with Neglecting a Child (Consequence is Sex Offense) and Neglecting a Child (Consequence is Bodily Harm). A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate neglect to the infant by the mother and physical abuse to the infant by the mother's significant other. The agency determined the infant unsafe, and the infant was taken into Temporary Physical Custody and placed with her father. A Petition for Protection or Services was filed, and the case remained open to provide ongoing case management services.
