**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On June 26, 2025, the agency received a report regarding a 7-month-old infant pronounced deceased. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner’s Office noted no signs of trauma to the infant; the autopsy report is pending. No criminal charges have been filed in this case, and the investigation remains open.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Medical Examiner’s Office noted no signs of trauma to the infant; the autopsy report is pending. An independent Initial Assessment found insufficient evidence to substantiate neglect of the infant by the court-ordered relative caregiver. The agency determined the relative caregiver’s other children to be safe and they remained in the home. The case was closed upon completion of the Initial Assessment.

At the time of the incident, the infant was residing with a court-ordered relative caregiver. The infant was placed in out-of-home care on January 8, 2025, after she was taken into Temporary Physical Custody due to allegations of neglect by the mother.

At the time of the incident, the infant resided with her court-ordered relative caregiver, the relative caregiver’s significant

other, the relative caregiver's 1-year-old, 7-year-old, 8-year-old, and 11-year-old children, and two of the relative caregiver's adult relatives. There were no other children placed in out-of-home care with this relative caregiver at the time of the incident.
