Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On December 27, 2012, the agency received a report regarding a one-year-old child admitted to the hospital in critical condition due to alleged medical neglect. It was reported the child presented as "almost dead," after she did not receive her medication as prescribed for life-threatening health conditions. The report indicated that on the previous day the child's parents tried to wake the child and found her unresponsive. The parents were previously told by medical professionals to bring the child immediately to the emergency room if that occurred; however, the parents waited almost 19 hours before doing so. The child was assessed by medical personnel and then transported to a larger hospital due to her grave condition. The child was described as "completely devastated neurologically" because of the incident. The mother admitted she forgot to administer emergency medication for the child but said she was trying to contact the child's doctor. Emergency rescue was contacted early the next morning and the child was transported to a local emergency room. As a result of law enforcement's investigation, the mother was criminally charged with Neglecting a Child (Consequence is Great Bodily Harm) and 1st-Degree Recklessly Endangering Safety. A criminal charge is merely an allegation and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate the maltreatment of neglect to the child by the mother. Medical professionals determined the child suffered neurological damage and brain injury due to the parents' delay in seeking medical care after the child became unresponsive. The agency determined the child unsafe and placed her in out-of-home care with a relative. A Child in Need of Protection or Services petition was filed and the case remained open to provide ongoing case management services.

On November 16, 2011, the agency screened in a CPS Report alleging medical neglect to the child by the mother. An assessment was completed, and the allegation of neglect was unsubstantiated. The family was referred to community resources and the case remained open with the agency for voluntary ongoing services. The family received ongoing services from December 5, 2011 to December 29, 2011, at which time the case was closed and the family continued to receive services in the community.

On November 16, 2011, the agency screened in a CPS Report alleging neglect to the child by the mother. An assessment was completed, and the allegation of neglect was unsubstantiated. The family was referred to community resources and the case remained open with the agency for voluntary services.

On January 5, 2012, the agency screened in a CPS Report alleging medical neglect to the child by the mother and the father. An assessment was completed and the allegation of neglect was unsubstantiated. The agency determined the child was safe in the home and was receiving all necessary medical care. The family continued to receive services in the community, so the agency closed the case.
