Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On June 2, 2014, the agency received a report regarding a six-month-old child brought to the hospital with head injuries. The report stated the child fell to the concrete when she was being removed from her car seat which was not properly secured. It was reported that the child presented as drowsy, cried and vomited several times so the family transported the child to the hospital. While at the hospital, medical personnel observed the child who was sent home after she was able to tolerate food.

The next morning the child continued to experience vomiting so the family brought the child to her primary care physician. Medical personnel observed the child to have a high temperature and red ear. Additional testing was completed which indicated there was chronic subdural bilateral bleeding and new acute subdural bleeding.

No criminal charges have been filed in this case, but the investigation remains open.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found a preponderance of evidence to substantiate maltreatment of physical abuse to the child by her mother. The child was deemed unsafe and taken into Temporary Physical Custody. Upon discharge from the hospital, the child was placed in out-of-home care. A Child in Need of Protection or Services petition was filed and the case remained open to provide ongoing case management services.
