**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On July 7, 2015, the agency received a report regarding one year old male twins brought to the hospital with severe injuries. Medical professionals who examined the children's suspected abusive trauma due to the children's presenting symptoms. One of the infants died as a result of the injuries. Law enforcement was contacted and initiated a criminal investigation regarding the children's suspicious injuries. Medical personnel diagnosed the children with Physical Abuse-Abusive Trauma. As a result of law enforcement's investigation, the mother was arrested and criminally charged with Neglecting a Child (Consequence is Death), Neglecting a Child (Consequence is Great Bodily Harm), Child Abuse-Fail/Prevent Bodily Harm, Child Abuse-Fail/Prevent Bodily Harm. The mother's boyfriend was also charged as a result of law enforcement's investigation. His charges include 1st-Degree Reckless Homicide and two counts of Child Abuse - Intentionally Cause Great Bodily Harm. A criminal charge is merely an allegation and a defendant is presumed innocent until and unless proven guilty.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the child by the children's mother and the mother's boyfriend. The agency also found a preponderance of the evidence to substantiate maltreatment of neglect by the children's mother. Medical professionals determined the children sustained significant injuries, one of whom died as a result of the injuries, and diagnosed the children with Abusive Trauma. The surviving infant and other children residing in the home at the time of the incident, were deemed unsafe and taken into Temporary Physical Custody. Upon discharge from the hospital, the surviving twin was placed in foster care along with his 2 year old sibling. The mother and mother's boyfriend are both incarcerated and are ordered no contact with the living children. A Child in Need of Protection or Services petition was filed and the case remained open to provide ongoing case management services.
