**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On February 9, 2016, the agency received a report regarding a 4-month-old infant pronounced deceased in her home. Medical professionals diagnosed the infant with premature birth and hydrocephalus. Law Enforcement was contacted and initiated a criminal investigation into the infant's death. No criminal charges have been filed in this case, but the investigation remains open.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate neglect of the infant by the mother. Medical professionals diagnosed the infant with premature birth and hydrocephalus and determined that the mother's lack of care contributed to the infant's death.

The infant's siblings were initially deemed unsafe due to the condition of the family home and temporarily stayed with a relative under a Protective Plan. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect of the infant's siblings by the mother. The infant's siblings were determined to be safe in their mother's care when she located appropriate housing. The family was referred to grief support services and the case was closed upon completion of the Initial Assessment.
