Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On March 4, 2016, the agency received a report regarding a 2 day old infant with head injuries. Medical professionals who examined the infant suspected head trauma due to the child's presenting symptoms, so the infant was transported to another hospital. Law enforcement was contacted and initiated a criminal investigation regarding the infant's injuries. Medical personnel diagnosed the infant with Subdural Hematoma. No criminal charges have been filed in this case, but the investigation remains open.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect of the infant by the mother. The Medical Examiner's Office completed report noted no signs of maltreatment or trauma to the infant and the injuries were determined to be caused by accidental means. The agency determined the infant to be safe. Due to the mother being incarcerated at the time of the infant's birth, the infant is currently residing with a non-relative caregiver pre-arranged by the family. The agency closed the case upon completion of the Initial Assessment and no service referrals were made.

At the time of the incident, the mother was opened for services with the agency due to a screened-in Services Report received on January 26, 2016 regarding the impending birth of her child while incarcerated. The last contact by the agency to the mother was on February 3, 2016.

On January 26, 2016, the agency screened-in a Services Report. The family was assisted with finding appropriate caregiver for the infant, once born, due the the mother's incarceration.
