Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On September 5, 2016, the agency received a report regarding an 11-day-old non-responsive infant brought to the hospital. Medical professionals intubated him and he was transported to another hospital. Medical professionals who examined the infant and diagnosed him with Abusive Head Trauma caused by non-accidental means. The infant died as a result of his injuries on September 18, 2016. The results of the autopsy are pending. Law enforcement was contacted, and as a result of law enforcement's investigation, the father was arrested and criminally charged with First Degree Reckless Homicide and Child Abuse-Recklessly Cause Great Harm. A criminal charge is merely an allegation and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the infant by the infant's father, as well as an unknown maltreater. Medical professionals who examined the infant determined the infant sustained head injuries and diagnosed the infant with Abusive Head Trauma. The infant died as a result of his injuries on September 18, 2016. The infant's sibling was deemed unsafe and taken into Temporary Physical Custody and placed in a foster home. The case remained open to provide ongoing case management services.
