Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On October 10, 2016, the agency received a report regarding a 2-month-old infant brought to the hospital unresponsive. Medical professionals who examined the infant suspected head trauma due to the infant's presenting symptoms, so the infant was transported to another hospital. Law enforcement was contacted and initiated a criminal investigation regarding the infant's suspicious injuries. Medical personnel diagnosed the infant with Physical Abuse-Abusive Head Trauma. No criminal charges have been filed in this case, but the investigation remains open.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the infant by the mother and father. Medical professionals determined the infant sustained head injuries and diagnosed the infant with Abusive Head Trauma. The infant and his sibling were deemed unsafe, taken into Temporary Physical Custody, and placed with relatives. A Child in Need of Protection or Services petition was filed and the case remained open to provide ongoing case management services.
