Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On October 16, 2016, the agency received a report regarding a 3-month-old infant pronounced deceased in her home by emergency medical personnel. Law enforcement was contacted and initiated a criminal investigation into the infant's unexplained death. The Medical Examiner's Office report noted no evidence of injury and stated the cause of the child's death as undetermined; several autopsy diagnoses are pending. No criminal charges were filed and the case was closed.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found insufficient evidence to substantiate neglect to the infant by the infant's mother. The infant's sibling was deemed unsafe, taken into temporary physical custody and placed with a relative. The case remained open to provide ongoing case management services.

At the time of the incident, the infant resided with her mother and her 9-year-old sister. The infant's 17-year-old brother occasionally visited the home. Paternity has not been established for the infant.
