Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On April 4, 2017, the agency received a report regarding a one-month-old infant brought to the hospital with concerns of malnourishment. Medical professionals who examined the child suspected maltreatment due to the child's presenting symptoms, and the child was transported to another hospital. Law enforcement was contacted and initiated a criminal investigation regarding the child's suspicious injuries. Medical personnel diagnosed the infant with Non-Organic Failure to Thrive. No criminal charges have been filed in this case, but the investigation remains open.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect to the infant by the father and mother. Medical professionals diagnosed the infant with Non-Organic Failure to Thrive. The infant and her siblings were deemed unsafe, a plan was developed to control for their safety in the home, and the children remained with their mother and father. A Child in Need of Protection or Services Petition was filed and the case remained open to provide ongoing case management services.

At the time of the incident, the infant resided with her father, mother, paternal grandparents, and 3-year-old and 1-year-old sisters.

At the time of the incident, the agency was initiating contact with the family to assess for possible service needs, in response to the March 9, 2017 screened-in Services Report. The agency attempted contact with the family several times, and had not yet established face-to-face contact. The last attempt by the agency was a voicemail for the family left on March 20, 2017.

On November 16, 2001, the agency screened-in a CPS Report alleging neglect to the infant's father by the infant's paternal grandmother. An assessment was completed by the agency and the allegation of neglect was substantiated. The case was open with agency for ongoing case management.

The agency collaborated with law enforcement and medical personnel to complete the assessment.
