**Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:**

On March 11, 2017, the agency received a report regarding a 5-month-old infant brought to the hospital with head injuries. Medical professionals who examined the infant suspected head trauma due to the infant's presenting symptoms. Law enforcement was contacted and initiated a criminal investigation regarding the infant's suspicious injuries. Medical personnel diagnosed the infant with Physical Abuse-Abusive Head Trauma. The infant was pronounced deceased on March 16, 2017. As a result of law enforcement's investigation, the father was arrested and criminally charged with 1<sup>st</sup> Degree Reckless Homicide. A criminal charge is merely an allegation and a defendant is presumed innocent until and unless proven guilty.

**Findings by agency, including maltreatment determination and material circumstances leading to incident:**

The agency collaborated with law enforcement and medical personnel to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the infant by the father. Medical professionals determined the infant sustained head injuries and diagnosed the infant with Abusive Head Trauma. The infant's siblings were deemed unsafe, a protective plan was implemented and the children remained in a separate household with their mother. The father was criminally charged and court ordered to have no contact with the infant's siblings. The case remained open to provide ongoing case management services.
